- **FY26 ROSC Projects mentioned by Landriah.**
 - *Increase the accessibility and availability of recovery supports with Shelby County, ensuring that individuals in need are aware of, and able to access recovery resources and services.*
 - *Establish DOPP Sites in the most rural communities of Shelby County for distribution of harm reduction materials.*
 - *Assist in establishment of a Safe Passage in Shelby County to assist those seeking support and transportation to treatment.*
- **FOOD SUPPORTS/PANTRIES/HOLIDAY MEALS** – **mentions to ask Susie Kensil if she knows more about Holiday Meals in the area. Council knows of and can share the Food Pantries of Shelby County list.**
- **Survey** - If anyone needs physical copies of surveys let us know now and we can get them out and collect them before December. **Mentioned by Landriah. Updated that we are at 128 surveys.**
- **Sober Fun Event – Spring into Recovery?** – **Mentioned by Landriah. Dawn Adrian from Family Life Center mentioned they are having an event on April 25th in the Shelbyville Park, it could be a collaborative event. Angie Hunt with Birth to Five mentioned she would be interested in collaborating as well.**
- **Opioid Settlement Funds**
 - **Strategy 1 – Support People in Treatment and Recovery – Beth mentioned that having Landriah write up a volunteer transportation prompt to share through email and on Facebook would be helpful for the council to make more impact. Landriah agreed and will write up a prompt for the council.**
 - **Strategy 2 – Prevent Overdose Deaths and Other Harms**
