3. Review Discussion:

168 surveys were completed. Plans to engage with older population of Clinton County senior residents in remaining 4 days survey is open. This population is currently unrepresented, and TAC would be grateful to receive their feedback. The Recovery Shop has officially moved. TAC is currently looking for “Home base” location but will continue remote work for now.

Currently working on the Strategic Plan. We are developing outreach/communication plan that will outline our work to maintain current relationships with community partners (sectors) and work to engage important community partners who have not been active in the council.

4. Committee Reports

TAC and council members discussed our current Mission and Vision statement. We decided to include mental health in the wording and work. We reviewed and discussed options presented by Sheridan. Alex shared HSHS community connection that outlines available community resources. Will bring info to the next, in person meeting.
