4. Old Business

a. Breaking the Silence-Domestic Violence in Recovery (Celebrating Domestic Violence Month)

- **Date:** Wednesday, October 22, 2025
- **Location:** 7810 South Claremont Ave, Chicago
- **Presenter:** Erica Bledsoe

This presentation explores the complex and often overlooked intersection of domestic violence and recovery. Participants will gain a deeper understanding of how intimate partner violence impacts individuals seeking or maintaining recovery from substance use and mental health challenges. The session highlights the role of trauma, power and control, and systemic barriers that can prevent survivors from accessing safety and supportive services.

Erica Bledsoe will guide attendees through recognizing warning signs of abuse, understanding survivor-centered and trauma-informed approaches, and identifying ways professionals, peers, and community members can provide safe, non-judgmental support. The presentation emphasizes empowerment, stigma reduction, and practical strategies for supporting survivors while promoting long-term healing and recovery.

This session is ideal for recovery professionals, peer support specialists, educators, advocates, and community members committed to creating safer, more responsive recovery environments.

b. Raw Survey Data

Kates Community Initiatives ROSC Council collects raw survey data to capture direct, unfiltered feedback from community members, service providers, and individuals with lived experience. The purpose of collecting raw data is to better understand community needs, service accessibility, recovery supports, and gaps within the local Recovery-Oriented System of Care.

Surveys are administered through multiple formats, including paper-based surveys, online platforms, and in-person distribution at community events and ROSC meetings. Demographic information is collected to ensure representation across age, gender, race/ethnicity, geographic area, and recovery status, while maintaining participant confidentiality and voluntary participation.

The raw data collected serves as the foundation for data analysis, reporting, and continuous quality improvement. Findings are used to inform program development, guide strategic planning, strengthen partnerships, and support data-driven decision-making that enhances recovery outcomes across the community.

c. Strategic Plan

The strategic plan for Kates Community Initiatives ROSC Council outlines a three-year roadmap (2025–2028) to strengthen a coordinated, community-driven Recovery-Oriented System of Care (ROSC). The plan focuses on enhancing infrastructure, expanding community engagement, improving data collection and evaluation, and increasing access to recovery supports.

It emphasizes the meaningful inclusion of individuals with lived experience, trauma-informed practices, and equity in service delivery. Through clear priorities, actionable goals, and measurable outcomes, the plan guides the Council in fostering partnerships, reducing stigma, and addressing gaps in recovery services. It also establishes a framework for accountability, continuous improvement, and long-term sustainability, ensuring that recovery supports remain responsive to the needs of individuals, families, and the broader community.
