## Discussion Notes

### SVVOR Updates

- Kourtnee Mezo noted that good people are hard to find; Amboy should be fully staffed next week, but Dixon is struggling.
- Both houses are currently full, with an okay wait list. It is difficult to retain women on the wait list.
- 31 intakes were completed last month.
- Gerald Lott wrote a book; half of the proceeds go to SVVOR. Available on Amazon, Barnes & Noble, etc.
- Hosted a Haunted House last month with 28 attendees.
- November documentary showing featured "Anonymous People" with ~35 attendees; next showing "Generation Found" on December 4th at 7:30 PM (free).
- Ongoing discussions with the Regional Office of Education about a feasibility study for a recovery high school.
- "Recovery Lives Here" campaign running with ads, radio spots, and a bus station sign in Dekalb.
- No events this month; roller skating planned for December.
- Cledy's House currently houses ~16 women; performing extremely well.

- Community survey ongoing; efforts needed to increase participation.
- Furniture and clothing available for peers moving into new places.
- Kourtnee expressed interest in becoming more involved in ROSC after limited recent participation due to staff issues.

## **Committee & ROSC Updates**

- Jake provided update on Recovery Friendly Workplace initiative; joined online chat group and received valuable resources. Follow-up meeting scheduled for Dec 3.
- Initiative in early stages; open to anyone wanting to join.
- Discussions about potentially moving ROSC meetings due to low energy in second meeting of the day; considering 3rd Thursday at 11 AM.
- Lauren and Gerald want to meet council members personally to improve engagement.
- Gerald, Jake, Lauren, and Shannon collaborating across counties; aim to join other boards to influence and have a voice.
- Jake joined Rochelle Area Community Foundation and is being considered for the Family Services Board.

- Ben looking into TGP transportation grant funding.
