### **Agency Updates**

The flyer can be found on the Chamber website and on Facebook! Becky also mentioned due to the cold temperatures there will be a reverse parade and a lot of activities are being moved indoors.

Skylar introduced Josh Forbes as the new Moultrie County ROSC Council Coordinator. Josh is continuing to train with Skylar. He is slowly taking over communication and outreach and will be chairing next month's ROSC Council meeting.

### **Community Survey**

Skylar shared the original goal was 750, we closed with 126 surveys completed. We are using this data to complete our FY26 Strategic Plan.

### **Events**

Josh mentioned that his first event will be in February 2026.

Skylar recapped the November Free Laundry Day, from 9am to 12pm. It was a successful event and we were able to interact with members we have not met from the Faith-Based community. They shared that they were happy with the event and are looking forward to future laundry days.

Our next Free Laundry Day will be on Thursday December 18<sup>th</sup> at Sullivan Wash and Fold, from 9am – 12pm or until funds run out.

Kandis has continued education groups at the Elizabeth Titus Memorial Library, every Monday 11-12. Skylar started discussion of possibly accrediting community service hours for attending in-person recovery education groups.

Kandis also gave us an update on the Community Narcan Training that ROSC will be presenting Monday January 26<sup>th</sup>, from 12pm – 1pm.

### **Priority Project #1**

*Increase the accessibility and availability of recovery supports within the County, ensuring individuals in need are aware of, and able to access recovery resources and services.*

Skylar mentioned her and Josh visited Harleys Hideout in Dalton City and they agreed to become a DOPP site. Narcan is also available at The Shamrock Pub in Dalton City.

### **Priority Project #2**

*Work with stakeholders to establish the use of MAR in local jails.*

We are still working toward this goal. Planning to have a MAR Symposium in Moultrie County.

### **Priority Project #3**

*Assist Moultrie County court in exploration of the development of a drug court.*

Skylar and Josh had a productive meeting with Moultrie County Probation about substance use and recovery in our community. We spoke with Mark Issacs about the involvement of other counties in the same Judicial Circuit.

Skylar informed Mark about some funding that is going to be made available regarding drug courts in rural areas.
