## Matt P.L.E Testimony

Matt started off by saying he has been on Drug Court for the last year, and he is currently on Phase 3.

He stated that within the last year his life has been turned around his kids are back in his life, and he's learned to be honest. He also stated he has taken up a leadership role as well. He has taken the roll of the trash pick-up coordinator. He mentioned the three rules of Drug Court are be honest, be on time, and do your best.

Q/A:

When asked by Mark; about graduation? He answered, there are two a year one in the fall and one in the spring.

When asked by Josh; How does drug court benefit a community? He answered, it has helped me become a productive member of society.

When asked by Sky; What happens if he successfully completes the program? He answered, all charges will be dismissed

Josh then thanked Matt for sharing and moved on to upcoming events.

## **Events**

Josh mentioned his first event will be Friday, February 20<sup>th</sup>, 2026.

He shared the name of the event is titled "Learning to Love Yourself and it will be held at the Mid-Illinois Senior Services Center in Sullivan, Illinois. Josh also mentioned he has a celebrity speaker Shawn Woods who has appeared in the T.V series Sons of Anarchy as well as full feature films such as Charlies Angels and Swordfish and how Shawn is a PLE and is going to share on how he learned to love himself through the process of recovery. Josh also mentioned they are Moultrie County ROSC Council will be partnering with DOVE Inc. for the event and there will be create your own valentine to yourself for children in attendance.

Josh recapped Free Laundry Day on December 18<sup>th</sup> from 9am to 12pm was successful and was able to interact with members of the Faith Based Community. They expressed their happiness with the event and are looking forward and very hopeful for future laundry days.


