### **New and Standing Coalition Reports:**

- SI SUPRT Community Survey reminder: Chris Dennis
  - Will end on December 8
  - Currently have 133 responses + a few dozen paper surveys to enter
  - Please continue to share
- ILNG Counterdrug Task Force Drug Trend Report:
  - Vincent Falzone presented several overdose data resources, emphasizing the IDPH overdose data dashboard and the NORC tool for analyzing trends across different states and counties. He noted that in 2023, there were 3,360 total overdose deaths in Illinois, with a significant percentage involving opioids and stimulants.
  - Drug task force currently works in Franklin and Saline Counties
    - Methamphetamine primary drug they are seeing
      - Some fentanyl and some cocaine
- Strategic Plan Overview: Chris Dennis
  - We need to create an Outreach and Communication Plan
    - What thoughts do council members have on how to reduce stigma within our communities?
      - Go to local high schools and have peers in recovery share their story
      - Talk about self-stigma
    - MAT/MAR Outreach – How do we effectively do this?
      - Explain how it works, how its used, and where to access it
    - Recovery Out Loud
      - Sharing events, what’s happening to stakeholders for them to promote the Recovery Movement.
        - Getting faces of recovery out there – small videos
      - Coffee with a Peer
        - At local libraries or coffee shops
      - Open Mic Night
      - County and/or Community Forum

- Reaching new stakeholders / those who may not initially support or understand the power of recovery
- Southern Illinois Recovery Network: Mike Tyson
  - Shyla informed everyone about planning for the next SIRN Conference for May 2026.
  - Next SIRN meeting is on December 10.
  - SIRN is now a 501C3 and has a Board of Directors.
- Narcan/Naloxone/Overdose Report, Naloxone Distribution Box, Fentanyl and Xylazine Test Strips: Drew Donelson, Katie Unthank
  - November 2025 Numbers
    - Number trained – 115
    - Number of kits distributed – 750
    - Lower numbers due to challenges receiving naloxone
  - Currently have fentanyl and xylazine test strips.
- Substance Use Disorder Staff Updates: Jerrie Baxley
  - Level 2 Intensive Outpatient to begin soon (hopefully early 2026)
