- **Introduction of attendees/agency updates**

- **Events** – reviewed by Landriah
 - Upcoming FREE Laundry Days @ Shelbyville Wash and Fold - 9am to Noon
 - February 12th, 2026
 - March 12th, 2026
 - April 9th, 2026
 - Landriah mentioned that there are 3-4 more months of funding left. There is a need for more donations for the community laundry days to help those in Shelby Co who need it.
 - Dawn mentioned that over the past year there have been more people attending laundry days if the funds are being used more.

 - Spring into Recovery: Shelby Co Sober Fun Day - @ Lake Shelbyville Pavilion – April 25th
- **FY26 ROSC Projects** – reviewed by Landriah
 - *Increase the accessibility and availability of recovery supports with Shelby County, ensuring that individuals in need are aware of, and able to access recovery resources and services.*
 - Conswala mentioned that she has a council that our council can get connected with to have more support, connections and ideas.
 - Landriah mentioned that getting the resource guides out is very important for the community and if anyone needs them emailed to them again to let her know.
 - *Establish DOPP Sites in the most rural communities of Shelby County for distribution of harm reduction materials.*

- Landriah mentioned that most of the small towns have DOPP sites currently. The two towns that still need DOPP sites are Sigel and Findlay.
 - Scott offered to support with bringing materials over to Sigel once they are called.
 - Kierra said she would look and see the next time she is headed towards Findlay and would help.
 - Dawn mentioned that Silk Purse needs added to the DOPP site list since it has newly become a DOPP site.
 - *Assist in establishment of a Safe Passage in Shelby County to assist those seeking support and transportation to treatment.*
 - Landriah mentioned that we still need to set a meeting with the Chief of Police and that the Volunteer Drivers Flyer will need to be distributed and blasted out once it is approved by admin.

- **Sober Fun Event – Spring into Recovery – April 25th**
 - Dawn shared how Family Life Center is already having an event on this day, the location is being moved from one area of the Lake to the pavilion area. There will hopefully still be a walk. She also commented on maybe having popcorn.
 - Nathan asked if having food trucks was an option. He mentioned that reaching out to Brenda Elder or Kaitlyn D, may be a good way of getting ideas for food, etc.
 - Conswala mentioned that she would reach out to Social Kitchen in the Belleville area to see if they have connections in our area.
 - Scott mentioned having a bags tournament. Also sent an email to the Health Dept to assess whether us serving popcorn at the event would be ok. He also mentioned ideas such as having a band and having the bubble pit that's used at the New Hope church for events there. If not for this event maybe for the one in June.
 - Landriah offered if anyone else wants to collaborate or be a part of the event, everyone is welcome.
- **Opioid Settlement Funds** – reviewed by Landriah
 - Strategy 1 – Support People in Treatment and Recovery

 - **Narcan Training – Feb 24th – 5pm to 7pm**
 - Landriah mentioned that we need other community resources to table and we also need two more individuals to speak on the discussion panel.
 - Conswala mentioned to check in with the medical stabilization department of the hospitals, assisted living homes or schools.

- Dawn mentioned to check in with the school guidance counselor or the sheriff's department; the coroner, funeral homes.
- Beth mentioned that SCCS and local social workers could be asked.

 - Landriah mentioned that help with filling resource bags would be really supportive.
