 - *Increase the accessibility and availability of recovery supports with Shelby County, ensuring that individuals in need are aware of, and able to access recovery resources and services.*
 - Angie Durbin will send updates on Drug Court info
 - Landriah Hardiek said her and Megan Ballard will start distributing newer resource guides to stakeholders and ROSC Council members.
 - *Establish DOPP Sites in the most rural communities of Shelby County for distribution of harm reduction materials.*

 - Dawn Adrian suggested The Gift in Findlay for a DOPP site.
 - Scott McKee suggested Sigel for a DOPP site, Kazbar.

 - Strategy 1 – Support People in Treatment and Recovery
 - Strategy 2 – Prevent Overdose Deaths and Other Harms
 - **Narcan Training – Early February – Event Space – Day/Time**
 - Tuesday, February 10th, decided upon for the event. 5pm to 7pm will be the time so people can come after work.
 - Dawn Adrian, Unity, Nathan Nichols and Beth Hayden are possibly interested in having a table.
 - Beth mentioned for Landriah to create a written ask for agencies to table and join the event. Landriah agreed.
