## **1. Call to Order**

The N8V Good Life ROSC Council meeting was called to order by Sherrine Peyton. The meeting opened in a good way with a prayer led by Gabriel Ayala.

## **3. Agenda Review and Approval**

The agenda was reviewed and approved as presented. Agenda items included:

## 4. ROSC Program Updates

Council members discussed hotline promotion and community response needs. A recent community incident was noted as an event that often increases hotline utilization, reinforcing the importance of continued outreach and visibility. Northwest CASA will bring materials to the upcoming community event.

## 5. Vision, Mission, and Language Decisions

The Council reviewed and affirmed its guiding statements:

- **Vision:** Living the Good Life.
- **Mission:** Supporting healing through Indigenous sharing.

Council members agreed that language should remain culturally grounded while remaining adaptive over time. Consensus was reached to use the term “**cultural sharing**” in public-facing materials rather than “**ceremony**” in order to respect intertribal differences, avoid misinterpretation, and reduce potential cultural or political harm. Internally, culturally specific language may be used when appropriate.

## 6. Healing Framework and Grant Alignment

The ROSC planning framework—assessment, capacity building, planning, implementation, and evaluation—was reviewed. Council members confirmed alignment with Indigenous wisdom, including mental, emotional, physical, spiritual dimensions, and the teachings of the grandfathers and grandmothers. Technical assistance confirmed that adapting language to be culturally appropriate is aligned with IDHS/SUPR expectations. It was noted that this is the State of Illinois’ first Indigenous ROSC.

## 7. Resource Guide and Documentation

The Indigenous Recovery Support Services Resource Guide was reviewed. The guide includes treatment services, peer recovery support, harm reduction services, housing, healthcare, legal services, community assets, and powwow listings. The guide will be updated on an ongoing basis and shared through the ROSC webpage. The long-term goal is to convert the existing Excel spreadsheet into a digital flipbook housed on the Trickster Cultural Center and CPYD Coalition websites.

## 8. Community Survey Results

Key findings from the community survey (N = 128) were reviewed:

- Persistent stigma toward people who use drugs
- Limited awareness of Medication-Assisted Recovery (MAR)
- Limited understanding of harm reduction strategies
- Strong interest in Indigenous cultural healing practices

It was noted that some Indigenous respondents were unsure whether MAR includes traditional medicines. Survey findings will inform strategic planning and goal development.

## 9. Strategic Planning and Next Steps

The Council will finalize two to three SMART goals aligned with assessment findings. An extension will be requested to allow for full Council review and input.
