#### **2. Review Discussion: Survey Data & Strategic Plan**

Strategic Plan was presented to the council & will be included in email send out and on GSU.

Key gaps identified in survey data:

- Only 14% of respondents reported knowing where to access substance use and mental health services.
- Only 3% of respondents reported knowing where to find Medication-Assisted Recovery (MAR) services.
- Survey data highlights limited awareness and access to available services.
- Stigma and community attitudes:
- Negative stigma toward individuals with substance use and mental health challenges remains a significant barrier.
- 93% of respondents believe alcohol use is a problem in Clinton County.
- 78% reported knowing someone with a substance use disorder.
- 70% of respondents believe people who use substances deserve respect, indicating that 30% do not.

We updated our mission and vision statement slightly to incorporate mental health more into the core-message:

- Council Mission: Cohesive partners developing comprehensive strategies involving education & prevention, law enforcement, family support, treatment and recovery services.
- Council Vision: Reduce the impact and stigma of substance use and mental health

among the residents of Clinton County.
