An email from Summer Phillips with the Douglas County Health Department was shared with the council about a positive experience she had while visiting a local restaurant. Summer stated that she was unsure when we might see a shift in stigma but that the day had finally come. She was able to witness it in a group of local people who were talking at the restaurant. One was talking about how they had Narcan they picked up from a local library and it was to hopefully help save a life. Another person said they their spouse wanted to have Narcan for after an upcoming surgery so they were going to pick some up from the same library. Summer heard the person say this and had some Narcan with her so she left it on the windshield of the person's car (she knew what they drove). Summer wanted everyone to know it takes time and is a group effort to reduce stigma but we are making progress.

### **Updates related to Priority Projects- Transitional Housing, MAR, Drug Court**

- Update for transitional housing – working to get the HVAC system installed. Funding is needed to finish this project. If you know of any grants or other ideas to help with the cost let Lyndsey know and she can pass information on. The service agreement with probation is still being finalized. Next Transitional Housing Meeting is February 4<sup>th</sup> 10am at PJ's Place.
- We hope to have a meeting of the Drug Court Team in February. The team is searching for a coordinator. We do still plan to connect with Mr. Blundell who can help the team with guidance on the start of Drug Court. Lyndsey has been attending other Dug Court sessions in surrounding counties to learn more about how theirs are ran and has spoke with participants to hear about their experience.
- Lyndsey will reach out to the contact at Carle provided by Christine about hosting another free community MAR and Harm Reduction session
