Strategic Planning Discussion

- **Goal 1**
 - **Objective: Develop and post at least 12 stigma-reduction social media posts targeting a 5% increase in engagement (likes, shares, comments) by March 30, 2026.**

Funded in whole or in part by the Illinois Department of Human Services, Division of Behavioral Health and Recovery



- **Brainstormed Post Types**
 - Myth vs. Fact Posts
 - Highly engaging.
 - Challenges long-held beliefs.
 - Educational and easy to share.
 - Personal Stories- Most powerful when local but barriers: privacy concerns in small communities (*options discussed- Anonymous/local demographic identifiers (e.g., “Livingston County resident, age 37”)*); Composite stories based on real data.
 - Data Points / Visual Infographics
 - Age demographics seeking services - Gender, occupation, or other trends.
 - Column charts/visuals to normalize help-seeking behavior.
 - Polls (Interactive Engagement)
 - Pre/post perception polls.
 - Series-based approach (build knowledge across 11 posts, final post measures change).
 - Potential question: “Where would you like to see Narcan available?”
- **Calls to Action**
 - “What can you do at home/work/school?”
 - Focus on language, acceptance, and support.
 - Promote local resource guides:
 - IHR resource guide
 - OSF resource guide
 - County online resource list
- **Key Considerations**
 - Immediate engagement vs. long-term stigma reduction.
 - Stakeholders should share/boost posts.
 - Continue messaging beyond March 2026 for long-term impact (community survey tracking).
- **Goal 2**
 - **Objective: Identify community harm reduction needs through existing partnerships by February 15.**
 - Narcan Distribution Discussion (Known Distribution Locations):

- Cornell - Town hall currently stores Narcan in Styrofoam cooler; New newspaper-style box purchased.
- Narcan Distribution Discussion (Potential Locations for Additional Narcan Boxes)- Focusing on Retail / High Traffic
 - Gas stations- Casey's (Route 17); Love's / travel stops (county boundary considerations)
 - County Market
 - Dollar General
 - Smoke shops
 - Hotels
 - Community college
 - Rec Plex
 - Salvation Army
 - Pawn shop (product distribution approved; vending box not approved)
 - Laundromats (especially 24-hour)
 - Post offices (research needed re: USPS/property ownership)
 - Amtrak stations
 - Rest stops
 - Parks- Suggested (Riverside Park, Lions Park)
 - Concern: vandalism, perception, child safety issues
- Key Concerns
 - 24/7 accessibility preferred.
 - Temperature control (2-year shelf life; extreme heat/cold impact).
 - Vandalism risk.
 - Maintenance and monitoring.
 - Long-term funding sustainability.
 - Stigma and privacy—location must feel discreet and safe.
- Action Items
 - Health Department drafting grant proposal (due Feb 15).
 - Mental Health Board may fund box purchases (maintenance not included).



- Research USPS/post office placement feasibility (Health Dept + Mental Health Board).
- Subcommittee meeting Feb 11.

- **Goal 3**
 - Objective: By Dec 2026, engage elected representatives regarding needs, gaps, funding, and education.
 - Current Political Landscape
 - Jason Bunting – Responsive; aligned with social services.
 - Sen. Balkam – Action-oriented; focused on workforce/childcare; requires business/economic framing.
 - Rep. Tipword – Likely exiting office.
 - Potential new candidates emerging.
 - Key Takeaways- Must Present:
 - Clear problem
 - Concrete ask
 - Defined action step.
 - Suggestion to focus on workforce impact, economic productivity, business capacity, social services support, etc.
 - Engagement Strategies
 - Coffee with the Candidate events
 - Listening sessions
 - Campaign stops
 - Office meetings
 - Debates
 - Leverage connections (e.g., Deb Howard)
