Guest speaker: **Barb Gibson who is a member of PAL (Parents of Addicted Loved Ones) Group**

Barb shared with the council about how she got involved with the PAL Group about three years ago. The group is based out of Phoenix, AZ and was started in 2006 by Michael Speakman. She spoke about how there is a meeting every day of the week that people are welcome to attend. Parents, spouses, and siblings 18 years of age and older are welcome. Everyone does spend some of the time during group working on a lesson and some of the time sharing and supporting one another. There is an optional book that people can purchase and attend the group is free. Barb has found the group very beneficial to her. She has been exploring the idea of starting a local group for those in Douglas County and the surrounding areas to attend. She is looking at possible spaces that can be used for in person attendance. After that is set up she will be able to start her training to then be able to host the meetings.

### **Updates related to Priority Projects- Transitional Housing, MAR, Drug Court**

- Update for transitional housing –the flooring was installed in the sleeping area of the house. And some new ceiling fans were installed. Linda is always on the lookout for any grant opportunities. She can also present at groups about the mission of her organization. Next Transitional Housing Meeting is March 4<sup>th</sup> 10am at PJ's Place.
- The next meeting of the Drug Court Team is March 31st. Brody Good is now the Drug Court Coordinator. Mr. Blundell from the state office of problems solving courts plans to attend the March meeting to help offer guidance and answer questions. The team is to be reading up on the statutes, trainings, and reviewing an example of a Drug Court participant handbook that has been provided by Brody. Brody is also meeting with AOIC Grants Manager Lynn Moore to go over a few potential grant opportunities.

- Lyndsey is meeting with Dave King from the Carle Addiction Recovery Center for assistance on hosting another free community MAR and Harm Reduction session within the next few months.
