

Clark County ROSC Council – January Meeting Minutes

1. Call to Order

The meeting was called to order to provide updates on current recovery initiatives, review progress on strategic priorities, and coordinate planning for upcoming education, outreach, and community engagement activities in Clark County.

2. Overview of Key Discussion Areas

Community Outreach and Program Updates

- Bobbye Scott provided an overview of recent outreach and council activities. Updates included planning for the upcoming Free Laundry Day event on April 15th, with final participation and outcome details from January's Free Laundry Day to be shared once available. The group also discussed an outreach event scheduled for March 13th, focused on education and engagement around drug court and community safety.
- Jessica Parrill, ROSC Council Navigator shared updates on recovery engagement efforts in Clark County, including recent peer lived-experience connections and volunteer activities at the Marshall Thrift Store. Narcan training completed during volunteer work was discussed, along with continued stigma and misconceptions surrounding Narcan education.

Narcan Implementation and Harm Reduction Efforts

- Bobbye discussed recent Narcan implementation within a facility, noting mixed initial responses from staff. She shared that through education and discussion, some staff have become more receptive and have begun utilizing harm reduction practices. An event involving reaction to a person with SUD (substance use disorder) was discussed as an

example of the ongoing need for trauma-informed and compassionate approaches across service systems.

Strategic Planning and Organizational Alignment

- Bobbye shared updates on revisions to the ROSC Council Strategic Plan. The revisions provided additional clarity on organizational direction and alignment with grant goals and community needs. The group reviewed how current initiatives align with strategic priorities related to harm reduction, recovery housing, drug court development, education, and stigma reduction.

Recovery Housing Planning

- The group discussed ongoing recovery housing planning efforts, emphasizing the importance of proactive education to address stigma and misconceptions. Bobbye outlined plans to coordinate an informational campaign and outline an action plan for recovery housing based on community input, to be completed by the end of the fiscal year (June 30).

Kratom / 7-OH Ordinance Updates

- Bobbye provided updates on the collaborative 7-OH and Kratom initiative with HRC, noting continued outreach to city boards regarding ordinance adoption. She shared insights from a conversation with an individual in recovery from 7-OH/Kratom and discussed plans to coordinate a meeting for lived experience storytelling to support education and policy efforts.

Meeting Scheduling and Participation

- The group discussed potential changes to meeting frequency and scheduling to improve participation and alignment with potential stakeholders, HRC and probation schedules. Members agreed to Bobbye monitoring feedback and finalizing a regular meeting day and time after the January 27th meeting with Probation and HRC.

Community Events and Engagement Planning

- Bobbye facilitated a discussion on future community engagement activities, including family-focused and recovery-friendly events such as a "mommy and me" event, financial literacy programming, and other fun recovery-centered activities. The goal is to host at least two additional recovery-focused activities before June 30, coordinating with priority events and community partners.
