ROSC Definition

A Recovery Oriented System of Care (ROSC) is a coordinated network of community-based services and supports that is person-centered and builds on the strengths and resilience of individuals, families, and communities to achieve abstinence and improved health, wellness, and quality of life for those with or at risk of substance use or mental health challenges. The central goal of the ROSC is to create an infrastructure or system of care with the resources to effectively address the full range of substance use and mental health issues within communities. The underlying premise of the ROSC is to promote recovery, the process of change through which individuals improve their health and wellness, live self-directed lives, and strive to reach their full potential as defined by SAMHSA.

Mission Statement

Macoupin and Montgomery County ROSC seeks to (1) reduce stigma and increase engagement among community members, (2) improve awareness of substance use and mental health through education and outreach, (3) facilitate cooperation across sectors, perspectives, and lived experiences, (4) increase access to multiple recovery support options and timely care, and (5) increase the number of people pursuing and maintaining recovery.
