II. FY26 Quarter 3 Strategic Planning – Cat explained this meeting will focus on Quarter 3 Planning and divided the council members into 3 breakout rooms to each discuss the following:

1. Rural resources for substance use disorder and mental health.
 2. Veterans - substance use disorder and mental health
 3. Families
- ii. *Who are 3 potential subject matter experts that could deliver training on the identified community training topics?*
 1. Adrienne Sutter – Focus on rural populations
 2. Narcan Trainings
 3. Trainers that specialize in substance use disorder and the families of loved ones with a substance use disorder/co-occurring disorders.
 - iii. *What are potential community locations for hosting the FY26 Q4 training?*
 1. Steve Bridges discussed an upcoming Illinois Joining Forces Summit in July that he is working on, however, it is in July, but he would like to explore having a breakout session on Narcan Training.
- b. Goal 2: Support and Promote Harm Reduction**
- i. *What effective community outreach strategies should be used to increase Narcan distribution in McLean County?*
 1. Check in with local police, EMTs, and first responders if they are up to date on training and if they need Narcan® for distribution.
 2. Create educational materials dispelling myths surrounding harm reduction and Narcan.
 3. Look for data that is public record on concentrated geographic areas where overdoses are being reported from police records.
 - a. Promote Prevention First Harm Reduction Echo series on McLean ROSC social media and council members.
 - ii. *Who are potential community organizations to collaborate with to host 2 Narcan administration trainings in FY26 Q3 and Q4?*
 1. High schools/schools
 2. Regional Alternative School
 3. YouthBuild
 4. Project Oz
 - iii. *What are potential community locations for hosting Narcan administration trainings in FY26 Q3 and Q4?*
 1. Utilize police overdose data to triangulate potential businesses, churches, and organizations to serve as community locations.

3. Ideas for Outreach Approach

- a. Individual one-on-one outreach, in person, specifically the department chairs
- b. Recruiting an ambassador, such as someone on the board of a Greek organization or an RA, to be the 'go-between' or liaison from our coalition to theirs.
- c. Besides colleges, the group also mentioned local police stations as a sector to continue outreach with, specifically the individuals in charge of community engagement.
