Program Description:

Globalization is an important phenomenon affecting all countries. An understanding of the political, legal, and economic (formal and informal) characteristics of another country deepens a student's understanding of how interconnected our world is, facilitates a deeper appreciation of the impact of globalization in the United States, and clarifies the roles of markets and governments in generating economic growth.

South Africa is the powerhouse of Africa. It is the driving force behind African growth. It has the most advanced, broad-based economy in Africa, and its infrastructure matches that of any first-world country. South Africa is ranked 39th place in the world for ease of doing business by the World Bank and International Finance Corporation (IFC). However, South Africa's culture and economy can make doing business there, a tricky endeavor. The South African economy is dominated by large corporations with a relatively underdeveloped small and medium enterprise sector. Meetings are rather informal when compared with the United States.

Whether or not a student's academic or professional interests are focused on South Africa, this program is designed to help the student gain a better understanding of the differences and similarities between the U.S.A. and other countries and broaden their horizons. While the small details learned in the program might be focused on South Africa, the comparisons and critical thinking that will take place will help the participant in any business endeavor be it domestic or international, with South Africa or with any other country.

Program Costs:

Cost: \$3,900*

Scholarships & Grants:

***IU CIBER GRANT**: Thanks to the Indiana University Center for International Business Education and Research Grant, the College of Business will reduce the program fee by \$600 for the first 16 applicants!

GSU Study Abroad Scholarship: Typically awards between \$500-750 towards the program fee.

Deadlines:

Application & \$500 Deposit Deadline: July 1, 2019 Other Payments Due:

> August 1 - \$500 September 1 - \$500 October 1 - \$1,000 (Financial Aid & Study Abroad Scholarship can assist with this payment, if applicable) November 1 - \$1,400 or remaining balance (IU CIBER grant will reduce price by \$600, therefore the total due would be \$800)

Study Abroad Scholarship Deadlines:

- o June 15 (early application funds cannot be used for deposit)
- o September 15 or October 15

Other:

Vaccinations: None required unless travelling from a country with risk of Yellow Fever (U.S. is not one of them). Consult <u>www.cdc.gov</u> and your doctor about other vaccine recommendations such as Hepatitis A, Typhoid and Malaria.

Passport: Passport must be valid for at least 30 days upon departure from South Africa.
