Dear Colleagues,

It is with great pride and pleasure that Academic Affairs and the Office of Sponsored Programs and Research presents its fiscal year 2020-21 annual update on grants activities and Governors' State University.

As you will see in the attached report, our campus has been tremendously and consistently successful in being awarded grants that support teaching, scholarship, and service to the community. In 2020-21, faculty and professional staff were awarded 35 unique grants totaling \$22m in alternative revenue for campus operations. While there are too many to comment on invidually, we have used our grant frunds to enrich the lives of students, provide professional training in key areas, meet emerging health and safety needs brought on by COVID-19, and contribute to the arts and culture of the Southland.

Reading the report, ably prepared by our Director of OSPR, Rasha Abed, you will also see that we have increased our number of federal, state, and local government grant awards and the overall dollar value of all awards between 2017 and 2021 has increased from \$11m to \$28m for a grand total of nearly \$60m in the past four years.

As part of the launch for the new academic year, the Office of President in collaboration with the Office of Academic Affairs and the Office of Sponsored Programs and Research will be hosting a special recognition of the outstanding work of the GSU community in building capacity through our robust culture of grants and sponsored research.

Congratulations to all our ocmmunity who has been actively participating in advancing access, quality, and knowledge through grants and sponsored research!

## Message from the Director of Sponsored Programs & Research



Resiliency is what fiscal year 2021 was all about at GSU! Many of us were pushed to new limits, and as a community had to bend to thrive. Still, with all of its challenges, we had opportunities to impact students in new ways. Collectively, we readjusted our expectations of ourselves and others, and were able to more clearly see the challenges that many individuals in our communities must overcome in order to achieve success in their academic studies. The pandemic's impacts flowed through agency funding priorities and throughout this year's portfolio of new grant awards. I wanted to take a moment to touch on activity that occurred from July 1, 2020 through June 30, 2021.

As most people are aware, in March 2020, the World Health Organization declared the spread of Coronavirus Disease (COVID-19) a worldwide pandemic.

The CARES Act provided funding through the Education Stabilization Fund Program Governor's Emergency Education Relief Fund (GEER). During Fiscal Year 2021, GSU received \$1.92 million in GEER funds from the Illinois Board of Higher Education. The

funds supported our efforts to enroll and retain low-income, underrepresented and first-generation students who might not otherwise enroll or return due to the pandemic, including by closing digital equity gaps. Additionally, we were able to deepen our math and english language instruction for specific populations in need.

GSU submitted two focused initiatives to continue to provide resources that assist in advancing the GSU mission of promoting persistence in degree completion while removing barriers to progression into upper division courses. GSU's **Gaining Enrichment through Educational Readiness** (GEER) program introduced a systematic approach to mentoring, intentional advising, resource support, aimed to support students persisting to degree completion. Additionally, the **Intensive English, Digital Literacy and Math Interventions** program was offered through GSU School of Extended Learning while the College of Arts and Sciences created a new math course to help students prepare for college-level math, a collaboration that strengthened partnerships across institutional units.

In fiscal year 2021, through the Coronavirus Response and Relief Supplemental Appropriations Act (CRRSAA) and the American Rescue Plan (ARP), the University received \$17,209,855. Of that, \$7,139,371 was used to provide students with financial aid grants to be used for any component of the student's cost of attendance or for emergency costs that arose due to COVID-19, such as tuition, food, housing, health care (including mental health care) or child care. GSU has been using the balance of \$10,070,484 to defray expenses associated with COVID-19, including lost revenue, reimbursement for expenses already incurred, technology costs associated with a transition to distance education, faculty and staff trainings, and payroll. We have attempted to address students' needs through mental health and advising support, hiring additional faculty to encourage social distancing and mitigating COVID-19 risk by increasing cleaning protocols on campus.

Not surprisingly, the arts have been an avenue for working through not only the pandemic's impacts but our more recent conversations around race as a country. **The SOUL of the SOUTHLAND**, a Healing Illinois program funded by the Illinois Department of Human Services (IDHS) and led by Drs. Rogachevskaya, Deborah James, etc..., is an initiative grounded in our mission of equity focused justice education. The project utilized art-making, media, and education opportunities while listening, empowering community voices to speak and apply culturally- competent behaviors in their daily lives, and artistic expression promoting racial healing.

This annual report is meant to provide a brief snapshot of the strong faculty and staff sponsored programs and research activities, much of which is focused on providing GSU students with opportunities to be competitive in the world.



### Featured Grant Updates

Jun Zhao, College of Business
U.S. Department of Commerce - \$578,884

Fostering Supply Chain and Logistics Innovation in Chicago Southland

GSU was one of 52 awardees of the 2020 Build to Scale challenge funding administered by the Economic Development Administration (EDA). The program provided \$578,884 in federal funds over three years to support the operations of GSU's Illinois Innovation Network (IIN) hub, the Supply Chain Innovation Center and Business Incubator (SCICBI), which is the state's only supply chain and innovation hub. During the first year, SCICBI provided various certificate training programs to close to 100 individuals from more than 20 businesses and organizations in Chicago's southland region. COB faculty and SCICBI staff also helped several startups and small businesses improving their supply chain operations, develop e-commerce strategies, and expand international reach through consulting services. It also completed an economic impact study for the proposed South Suburban Airport. Strengthening relationships across that state is a focus of SCICBI and GSU's new leadership. In November of 2021, the team hosted leaders from GSU, the UI system, and state legislators on campus for a discussion on developing solutions for the local community to address global supply chain issues.

National Endowment for the Arts - \$60,000

Importance of Arts Participation for the Sense of Belonging and Acadmeic Outcomes of University Students of Color

The NEA grant supports the study titled "The Importance of Arts Participation for Sense of Belonging and Academic Outcomes of University Students of Color." The study explores how arts participation contributes to retention and success of university students of color. Our goal is to examine (1) the extent to which students' participation in the arts is related to their sense of belonging to the university and academic outcomes; and 2) the effect of students' participation in the arts on the relationship between the sense of belonging to the university and academic outcomes.

The first round of the study was completed in spring of 2021. An online survey was distributed to undergraduate students at Governors State University and its project partner, Northeastern Illinois University. In total, 435 responses were received; 134 responses were collected from GSU students. In addition to the survey two focus groups at each participating university were conducted in an effort to gain deeper insights about the importance of arts participation in students' life and how arts affect their experiences at the university.

The preliminary correlational results indicate that students' attitude towards the arts is positively and significantly related to their sense of belonging to the university. The greater the students' interest in the arts, the greater their reported sense of belonging. Additionally, the greater students' perceptions that their university was arts-infused, the greater their reported sense of belonging, their intention to persist in college, and their institutional commitment. The focus groups provided useful insights into the role arts play in helping students to express themselves, engage in self-care, and to develop curiosity or sociocultural insights. The students also shared their experiences with learning during the COVID-19 pandemic and the ways engaging in creating activities such as music, dance, and crafts supported their wellbeing.

#### Andrae Marak, College of Arts and Sciences Sharon Morrissey, School of Extended Learning

U.S. Department of Education- \$456,286

GEER- Intensive English, Digital Literacy and Math Interventions Program

One of nine IL institutions to receive a competitive grant through the Illinois Board of Higher Education Governor's Emergency Education Relief (GEER) Fund, Governors State University is realizing its mission to expand access to higher education for students and community members most in need.

College of Arts & Sciences (CAS) and School of Extended Learning (SXL) teamed up to recruit and retain low-income, underrepresented, and first-generation students who might otherwise not enroll or stay the course towards degree completion. GSU's program served two high-need groups— offering intensive English training, computer literacy, and mastering college concepts to ESL community members and providing additional support to existing GSU students through foundational math classes. The results have been encouraging.

Community partners including Spanish Community Center of Will County, Arab American Family Services, Prairie State College, Tinley Park School District 146, Chicago Public Schools, Workforce Development partners, and others contributed to the recruitment efforts. Director of the English Language Learning Center (ELLC), Dr. Akiko Ota, says it's working.

"ESL participants have already been accepted at two and four-year institutions, including GSU, Prairie State College, South Suburban College, and the University of Illinois Chicago. Others are interested in pursuing career training through the Workforce Innovation Opportunity Act (WIOA) funding process. We are excited to see the positive impact of the program," Dr. Ota said.


Co-PI Sharon Morrissey, Director of Strategic Initiatives for SXL said, "We believe English is the key to academic and career readiness, and we're so impressed with these ESL students. Many participants are parents and mothers, and they have persisted through unforeseen changes in the different schools districts that their children attend (switching between online, hybrid and in-person instruction). They have balanced the demands of family and their studies and made their future aspirations a priority. We can all relate to the challenges they've faced and model their tenacity." So far, eight ESL students have either been accepted, or applied for, academic admission at Illinois colleges; half of them are looking to stay at GSU. SXL's third cohort is still running.

Morrissey is also encouraged by her collaboration with Dr. Andrae Marak, the Dean of the College of Arts and Sciences, and the resounding success of the math component of the grant. "The math component not only helps our existing students with the skills, knowledge, and confidence that they need to successfully complete the mathematics component of their general education but has also assisted us in building out the essential infrastructure needed to promote the success of our ESL students, and all future students, who enroll at GSU after they are done with the IEP program."

Ninety-six existing GSU students have benefited from the new math lab (MATH 2101) created by CAS to help students successfully complete college-level math. The one-credit, hands-on Statistics co-requisite, designed by mathematics faculty led by Dr. Chris Tweddle, offers 30 focused hours of math practice in a lab-format and serves as a complement to MATH 2100: Elementary Statistics. A unique aspect of the program offers students the opportunity to focus on real life social justice issues by using statistical concepts to analyze real-world data and explore questions about income inequality based on race, ethnicity, and class.

Marak said, "The new interventions have helped our largely first-generation students succeed in Elementary Statistics and, as a result, improve their overall academic achievements. We believe that the early results of this work provide a model that we can build on and replicate to continue to impact persistence and overall student success."



# Darcie Campos, Student Affairs and Career Services Illinois Board of Higher Education - \$24,350 Illinois Cooperative Work Study Program

The Illinois Cooperative Work Study Grant program, also known as the Student Training Experience Program or STEP on the Governors State University campus, offers an opportunity for the Office of Career Services to collaborate with local Chicagoland employers to provide paid internship opportunities for our undergraduate student population. The significance of being career ready is more important than ever, and this program gives GSU students the competitive edge needed to market themselves in the workplace upon graduation. Our students have an opportunity to develop strong career ready workforce skills and strengthen their knowledge by applying what they are learning in the classroom in a real world of work setting.

One of our grant employers, Craig Schmidt, the Vice President of Talent Development for Calumet Area Industrial Commission (CAIC), says "The STEP program at GSU has afforded CAIC the opportunity to bring on interns who are enthusiastic about learning but who also want to contribute. We would not be able to do this without this support." Anthony Robinson, a student intern currently working at CAIC, says, "I've enjoyed my internship at CAIC so much that I am extending it for the Spring 2022 Semester. The environment is open to suggestions when coming up with solutions to problems, and I feel a part of the team."

We look forward to seeing our students grow and expand their knowledge base over the course of the next semester. We are grateful for the continued funding we have been given by the Illinois Board of Higher Education to provide meaningful experiences for our students, and look forward to growing this program each and every year.

## Corey Williams, Student Affairs US Department of Education- \$1,464,103

Governor's Emergency Education Relief Fund (GEER)

Student support resources across at Illinois public institutions are limited during non-pandemic times but Covid-19 has tested these resources. What COVID-19 has further illuminated, and what this grant aims to address, is the need to build a communication framework to ensure that GSU students are connected with important services, and research gaps in student support. GSU's counseling and wellness center offers mental health services and immediate healthcare facilities through a partnership with Advocate Aurora Health; however, additional services are needed to fully address the public health crisis for the GSU community.

Higher education is a microcosm of the world and is not isolated from the effects of COVID-19. In a recent study, 90% of college and university presidents reported concern about student's mental health and only 17% reported being somewhat or extremely successful in ensuring students' emotional well-being. Before the pandemic, undergraduates were already at an increased risk to develop personal and psychological problems (Helber et al, 2012). A national study of first-year students reported 39% frequently felt anxious, 23% reported below-average emotional health, and 19% indicated they did not have adequate sleep (HERI, 2018). The same study reported 34% of first-year students felt their job responsibilities affected academics, and 35% felt familial responsibilities impacted their ability to be successful (HERI, 2018).

These concerns have become prevalent for GSU students, as we are minority-serving institutions and the pandemic has illuminated the racial disparities across the nation. In Illinois, people of color are disproportionately testing positive and dying from the virus compared to their White peers. People of color are also affected in regards to employment as 1 in 5 black and Hispanic women lost their jobs during the first month of the Illinois Governor's stay-home order.

GSU's Gaining Enrichment through Educational Readiness (GEER) program is intended to provide a multifaceted, comprehensive and systematic approach to provide mentoring, intentional advising, resource support, to support students persisting to degree completion. The primary goal of the program is to increase degree completion rates for low-income, first-generation, and minority students (both undergraduate and graduate).

Governors State University provides direct support for students through academic, social, mentoring and financial support. Students have the opportunity to apply for textbook and course material subsidies, laptops, Wi-Fi subsidies, and tuition relief. Additionally, a project coordinator, student success coach, social work, and peer mentors, provide guidance to students over the project period.

Over the fiscal year, GEER project staff focused on the following goals:

- 1. Retaining current GEER project participants;
- 2. Recruiting new participants into the GEER program for the fall 2021 term;
- 3. Implementing new programs for new and returning GEER participants;
- 4. Training paraprofessional staff to provide peer support; and
- 5. Distributing program supplies and financial support.

Healing Illinois is a racial healing initiative led by the Illinois Department of Human Services (IDHS), in partnership with The Chicago Community Trust, designed to distribute \$4.5 million in grants to organizations across the state to activate the work of racial healing. Governors State University received a \$30,000 grant that includes activities across several departments and disciplines.

As a Minority Serving Institution, Governors State University is committed to equity-focused justice education that equips social agents of change. The SOUL of the SOUTHLAND initiative activates this mission through art-making, media, and education opportunities—listening, empowering community voices to speak and apply culturally- competent behaviors in their daily lives, and artistic expression promoting racial healing. Connection, dialogue, and reflection will be achieved through campus partners including the state-of-the art Center for Performing Arts (CPA), the outdoor museum of monumental sculpture, Nathan Manilow Sculpture Park (theNate), Center for Community Media (CCM), and School of Extended Learning (SXL).

- 1) **BEYOND CONVERSATION:** a heartful movement for change uses arts as a springboard to discuss social issues aimed at actionable solutions. MPAACT podcast plays (Black and Blue; Feral) and Living Voices' The World of Anne Frank will provide raw experiential canvas for these discussions. These segments will bring artists, scholars, activists, and survivors to lean into tension and connect via a "virtual campfire:"
  - The Intersection of Opera and Race
  - Black, Blue and Beyond
  - Shaping our Narrative: Media Literacy, Accountability and Trauma
  - Through the Eyes of a Friend
- 2) SOUTHLAND HEALTH AND WELLNESS HOUR is a culturally tailored PODCAST (launched in 10.2020), produced by CCM, and hosted by Tonya Roberson, PhD, Director of Community Outreach. It breaks down health and wellness information, demystifies science concepts, connects community talk to actionable resources, and weaves together an inspirational listening experience. Distributed on Amazon, Apple iTunes, and Spotify, the podcast amplifies the diverse voices of our community leveraging Black, Latinx, vision and hearing-impaired perspectives on social, economic and ecological challenges into mainstream spaces.

- 3) Actions at the Nate invite healing with three interactive projects:
  - Wish for the World
  - Winter Walk
  - Empty Bowls

Through rock painting, nature tours, and communal art-making, participants from diverse backgrounds will learn, share, create and commemorate loved ones lost to violence while healing in nature, movement, and creativity.

**4) CULTURAL COMPETANCY TRAINING FOR CLASSROOM** brings race, gender and identify experts Dr. Joseph Flynn and Dr. Andrae Marak for workshops on shifting multicultural education in schools from tolerance to cultural competency by understanding how racism functions systemically. Educators will gain fluency in concepts, realities, and reactions to conversations about race. Topics will be presented in interactive group zoom sessions and breakout activities.



#### Updates from the Institutional Animal Care and Use Committee

Ethical and humane treatment of animals is paramount in instructional and research endeavors. The GSU Institutional Animal Care and Use Committee (IACUC) overseas and reviews all protocols involving vertebrate animals, conducts inspection of animal facilities and resources, maintains compliance with federal regulations and develops standard operating procedures and training guidelines. In fall of 2020, Erin Grey-Avis who had served as the IACUC Chair since 2015 left GSU. Dr. John Yunger replaced her as the new Chair.

Dr. Yunger is an active researcher and student mentor, whose current research projects focus on the role of small mammals in Cryptosporidium distribution along and urban-rural gradient, heavy metal accumulations by small mammals at abandoned mine sites, conservation of northern hardwood forests following settlement by Europeans.

In 2021, IACUC continued overseeing the project titled "Operation of MAPS bird-banding Station (Monitoring Avian Productivity and Survivorship) and Spring/Fall migration in IL" conducted by Drs. John Yunger and Diane Gohde. The project provided a learning opportunity for students in several courses in addition to outreach activities. The data from the study was sent to the national Bird Banding Laboratory, a unit within the United States Geological Survey (USGS). These data also go to the Institute for Bird Populations. For both organizations, the data are then used for conservation and management applications on a regional and national level.

#### Updates from the Institutional Review Board

In fiscal year 2021, the IRB received 100 applications, including 70 (70%) new studies and 15 (15%) amendments to previously approved studies. The remaining submissions were annual renewals and study closure reports. Forty four (63%) applications were received from faculty and 26 (37%) from student researchers. The largest share of new studies – 25 or 36% came from the College of Arts and Sciences, followed by the College of Education (23 studies or 33%), the College of Health and Human Services (14 studies or 20%), and the College of Business and Management (8 studies or 11%). By review type, the IRB received 63 (90 %) applications that qualified for exemption, 6 (9%) expedited applications, and 1 (1%) application requiring review by the full board.

In addition to conducting reviews and developing standard operating procedures, in FY21, the IRB's efforts were directed towards streamlining the review of student research applications. Recognizing the importance of faculty advisors in shaping student research, in September of 2020, the IRB hosted a session for advisors titled "IRB Review and Approval: What Students Need to Know and How Their Advisors Can Help." The IRB also initiated discussions with the administration of the College of Arts and Sciences about options for student capstone research. In addition the IRB partnered with the Division of Psychology and Counseling/College of Education to license SONA software in support of research studies that recruit students as research participants. SONA allows faculty and research administrators to create survey and lab studies, manage research schedules, screen participants for eligibility, track participants, and award credit for participation. SONA is housed in The Social Development Lab and managed by Dr. Alli Cipra.



### Featured Student-Led Research

This annual report highlights original research conducted by GSU students:

# IRB-FY2021-34 - Through their Recall of Lived Experiences: An Exploration of The Impact of Campus-based Support on The Retention of Former Foster Youth during Their First Year of Post-secondary Education (Sharva Hampton-Campbell/ Quincy Martin)

Many foster youth aspire to obtain a college degree. Financial support and campus-based support are available for these youth, but they are not always successfully graduating. This study seeks to understand the impact of support services on retaining former foster youth beyond their first year of college.

## IRB-FY2021-46 - Policy Implementation Strategies: State Education Policy Influence on Student Diversity in Dual Credit Programs (Alexandrea Horton/ Marlon Cummings)

The purpose of this study is to investigate how state education policies influence dual credit partnerships and student diversity in dual credit programs. Based on the findings, recommendations are provided for dual credit partnerships to encourage greater student diversity in dual credit programs.

## IRB-FY2020-148 - The Role of the Safe Passages Program in Policing the Heroin Epidemic (Karl Jurgens/Mary Bruce)

Safe Passage is a relief program offered by some police departments to assist non-violent opioid addicts find treatment facilities instead of charging them with a crime, such as possession of a controlled substance. This qualitative study explores whether or not Safe Passage is a program that all departments should pursue or if resources would be better utilized on other options. The findings highlight the challenges faced by Safe Passage programs, including high implementation costs, low rates of participation in the program, and insufficient advertising, to name a few.

## IRB-FY2021-42 - The Relationship between Resilience in Adults and the Characteristics of the Selfies They Post on Instagram (Tara Bryant-Edwards/ Tamekia Bell).

Resilience is a construct that reflects a constellation of personal, relational, and contextual factors that enhance the likelihood of positive outcomes in the face of challenges. The study examines the relationship between resilience and the attributes of the selfies that individuals have posted on Instagram.

External grant funding is a useful tool to enhance your scholarly pursuits. Some common activities that external grant funders support are:

- Research—Projects involving research that fits within the mission of the funding agency, whether it be basic, applied, demonstration, or clinical in nature.
- Training—Projects involving the training of students/ scholars in a special manner or for a specific purpose that is approved by the funding agency.
- Curriculum Development—Projects involving the creation or substantial revision of courses or programs that are research-based.
- Public Service—Projects involving research or instructional activities that benefit the institution or community.
- Fellowships—Support for an individual's own scholarly pursuits.

Governors State University subscribes to several searchable online databases that can help you find funding opportunities to suit your interests as well as useful information to enhance your proposal.

**GrantForward** offers an extensive database of funding opportunities, which are gathered from over 9,000 federal, state and private sponsors. However, GrantForward allows you to do more than just search for grants. With a researcher profile, you can receive grant recommendations related to your field and research interests. GrantForward uses your research interests, publications, and other profile information to recommend the best-fitting grant opportunities to you. 
