Minutes of the Wednesday, February 3, 2021 Meeting

Call to Order and Roll Call

Approval of Minutes

Chair Cevallos-Candau asked for a motion to approve the open session and executive session minutes of the December 8, 2020 Human Resources Committee meeting and to keep the executive session minutes closed pursuant to the recommendation of counsel. Trustee Kvedaras motioned. Trustee Harrell seconded. The motion was approved via a unanimous voice vote.

Information Items

Chair Cevallos-Candau asked President Cheryl Green and Therese King Nohos, Vice President, General Counsel, and Interim Vice President of Human Resources, to give an update on the leadership of the Office of Human Resources. President Green reported that Therese King Nohos will remain as Interim VP of HR for now and a search will be conducted for an AVP of HR, which will be a cabinet position. Discussion ensued.

Chair Cevallos-Candau asked Paul Bylaska, Vice President of Finance and Administration, to provide a COVID-19 update. Bylaska presented. Discussion ensued.

Action Items

Chair Cevallos-Candau asked for a motion to approve resolution 21-8, consideration and possible recommendation to approve 457(b) deferred compensation plan and employer participation agreement with the State Universities Retirement System deferred compensation plan. Trustee Harrell motioned. Trustee Kvedaras seconded. Vice President and General Counsel Therese King Nohos presented the motion. Discussion ensued. The motion passed unanimously on a roll call vote and the resolution will be recommended to the full board.

Chair Cevallos-Candau asked for a motion to approve resolution 21-9, consideration and possible recommendation to approve amendment and restatement of GSU Tax Deferred Annuity Plan. Trustee Harrell motioned. Trustee Kvedaras seconded. Vice President and General Counsel Therese King Nohos presented the motion. Discussion ensued. The motion passed unanimously on a roll call vote and the resolution will be recommended to the full board.

Executive Session

Chair Cevallos-Candau requested a motion to go into Executive Session at 8:36 a.m., pursuant to Section 2(c)(11) of the Illinois Open Meetings Act, to discuss pending litigation. Trustee Kvedaras motioned. Trustee Harrell seconded. Roll call was taken and Cevallos-Candau, Harrell, and Kvedaras voted to pass the motion.

The Board returned to open session at approximately 9:03 a.m. Chair Cevallos-Candau noted that no action was taken in executive session.

There being no new nor old business, the meeting adjourned at approximately 9:05 a.m. with a motion from Trustee Harrell and a second from Trustee Kvedaras. The motion passed unanimously on a voice vote.
