### **Approval of Minutes**

Chair Brookins asked for a motion to approve the minutes of the November 15, 2019 Governance and Nominations Committee meeting. Taboas motioned. Sebastian seconded. The motion was approved by unanimous roll call vote.

#### **Consideration of Recommendation for Slate of Officers**
