Approval of Minutes

Chair Kvedaras asked for a motion to approve the minutes of the November 30, 2020 meeting of the Academic Affairs Committee. Trustee Taboas motioned. Trustee Kvedaras seconded. The minutes were approved via a unanimous roll call vote of the two trustees in attendance.

Information Items

Chair Kvedaras asked Beth Cada, Provost and Vice President for Academic Affairs, and Paul Bylaska, Vice President for Finance and Administration, to present a COVID-19 update. Cada and Bylaska presented. Discussion ensued.

Chair Kvedaras asked Paul McGuinness, Assistant Vice President for Enrollment Management and Director of Admissions, and Colleen Sexton, Associate Provost and Associate Vice President for Academic Affairs, to present on the topic of reverse transfer of credit from GSU to community colleges so that students may be awarded a credential by their community college. McGuinness and Sexton presented. Discussion ensued.

Chair Kvedaras asked Corey Williams, Associate Vice President for Student Affairs and Dean of Students, Kelly Grab, Director of Community Standards and Student Advocacy, and Freddy Tung, Director of Counseling and Wellness to present an update on various student support services. Williams presented a GEER Grants Update. Grab presented a Student Support Services report. Tung presented an update on Student Support Services. Discussion ensued.

Chair Kvedaras asked Beth Cada, Provost and Vice President for Academic Affairs, to present the Accreditation Report. Cada presented, including the announcement that HLC, GSU's regional accreditor, recently approved GSU's first Ph.D. program (in Counselor Education and Supervision). Discussion ensued.

Action Item

Chair Kvedaras asked for a motion to approve resolution 21-7, consideration and possible recommendation to approve professor emeritus status. Trustee Taboas motioned. Trustee Brudnak seconded. Provost Elizabeth Cada presented the recommendation to grant Dr. Jane Rhodes Hudak professor emeritus status. The motion passed unanimously on a voice vote of the three trustees present, and the resolution will be recommended to the full board.

There being no old or new business, the meeting adjourned at 9:09 a.m. with a motion from Trustee Brudnak and a second from Trustee Taboas. The motion was approved by unanimous roll call vote.
