Approval of Consent Agenda

Chair Harrell asked if any trustee wished to remove an item from the consent agenda. No such request was made. Chair Harrell asked for a motion to approve all items on the consent agenda. Trustee Brookins motioned. Trustee Taboas seconded. The motion passed unanimously on a roll call vote.

President's Report

President Green delivered her report.

Closed Session

Chair Harrell asked for a motion to go into closed session pursuant to Section 2(c)(1) of the Open Meetings Act at 10:25 a.m. to discuss personnel matters. Trustee Kvedaras motion. Trustee Brudnak seconded. The motion passed on a unanimous roll call vote.

The Board returned to open session at 11:15 a.m. Chair Harrell noted that no action was taken in executive session.

Additional Action Items

Chair Harrell asked for a motion to approve Resolution 22-17, approval and adoption of the President's annual performance review for FY21 as recommended by the Human Resources Committee. Trustee Kvedaras motioned. Trustee Brudnak seconded. Trustee Kvedaras presented the resolution and also presented Resolutions 22-18 and 22-19. The motion passed unanimously on a roll call vote.

Chair Harrell asked for a motion to approve Resolution 22-18, directing the University to make a performance incentive compensation payment to President Green pursuant to her employment agreement equal to fifteen percent (15%) of her base pay by December 31, 2021. Trustee Kvedaras motioned. Trustee Brudnak seconded. The motion passed unanimously on a roll call vote.

Chair Harrell asked for a motion to approve Resolution 22-19, directing the University to increase President Green's base pay by five percent (5%), effective July 1, 2021, consistent with the Board's evaluation of the President's performance and pursuant to her employment contract. Trustee Brudnak motioned. Trustee Taboas seconded. The motion passed unanimously on a roll call vote.

Chair Harrell asked for a motion to approve Resolution 22-20, approval of Professor Emeritus status to Dr. Elizabeth Cada, Dr. Dianne Galante, Yvette Brown and Paul Blobaum and Associate Professor Emeritus status to Dr. Sandi Estep effective as of her retirement on or about January 29, 2022. Trustee Taboas motioned. Trustee Kvedaras seconded. Interim Provost Colleen Sexton presented the resolution. The motion passed unanimously on a roll call vote.

Chair Harrell asked for a motion to approve Amended Resolution 22-12, approval of the addition of Article VII to the Board Policies and Amendments to Article II, Section 2 and 3(A)(4)-(5) of Board Policies to reflect a university-wide discrimination policy. Trustee Kvedaras motioned. Trustee Taboas seconded. General Counsel Therese King Nohos presented the resolution and also related Amended Resolutions 22-13, 22-14, and 22-15. The motion passed unanimously on a roll call vote.

Chair Harrell asked for a motion to approve Amended Resolution 22-13, approval of an Amendment to Section II(A) of the Board Regulations to include an Anti-Discrimination, Harassment, and Retaliation Regulation. Trustee Brookins motioned. Trustee Kvedaras seconded. The motion passed unanimously on a roll call vote.

Chair Harrell asked for a motion to approve Amended Resolution 22-14, approval of an Amendment to Section II(A) of the Board Regulations to include a Title IX and Anti-Sex Discrimination, Harassment, and Retaliation Regulation. Trustee Brookins motioned. Trustee Taboas seconded. The motion passed unanimously on a roll call vote.

Chair Harrell asked for a motion to approve Amended Resolution 22-15, approval of an Amendment to Section II(A) of the Board Regulations to include an Accommodation for Employees with Disabilities and Pregnancy Regulation. Trustee Kvedaras motioned. Trustee Taboas seconded. The motion passed unanimously on a roll call vote.

Information Items

Chair Harrell invited Dr. David Rhea, Director of the GSU Honors Program, and honors students Kaylin Richey and Rachel Beckmann to present on their recent trip to the National Collegiate Honors Council Annual Conference. Dr. Rhea, Ms. Richey, and Ms. Beckmann presented.

Chair Harrell stated that the Board of Trustees meeting dates for 2022 were included in the board book.

Old Business/New Business

No old business.

Under new business, Chair Harrell congratulated President Cheryl Green on being named one of Crain's Chicago Business' 2021 Notable Black Leaders and Executives, adding that this award brings welcome attention to the University.

The meeting adjourned at 11:49 am with a motion from Trustee Brookins and a second from Trustee Taboas. The motion was approved by unanimous voice vote.
