# Governance and Nominations Committee Minutes of the Monday, December 7, 2020 Meeting

## Call to Order and Roll Call

There were no public comments.

#### **Approval of Minutes**

Chair Brookins asked for a motion to approve the open session minutes of the September 17, 2020 Governance and Nominations Committee meeting, noting that there was no executive session on that date. Trustee Taboas motioned. Trustee Koger seconded. The minutes were approved via a unanimous voice vote.

## **Information Items**

Chair Brookins introduced the first information item: Review of the Board of Trustees Bylaws, Policies, and Regulations. Therese King Nohos provided a report regarding information outlined in statute or GSU governance documents for undertaking such a review and the practices of other universities. Discussion ensued. Chair Brookins noted that the Committee would defer action on this item and requested that President Green, or her designee, prepare recommendations for the Committee's consideration regarding how the Board should review its Bylaws, Policies and Regulations.

Chair Brookins introduced the second information item: Review of Board Meeting Protocols. Sarah Boeckman provided a report regarding protocols outlined in statute or GSU governance documents regarding participation of shared governance campus groups and the practices of other Illinois universities. Discussion ensured. Chair Brookins noted that the Committee would defer action on this item and requested that President Green, or her designee, prepare a recommendation for meeting protocols.

Chair Brookins introduced the third information item: Criteria for Presidential Emeritus Status. Sarah Boeckman provided a report regarding criteria or policy outlined in statute or GSU governance documents regarding the awarding of president emeritus status and the practices of other Illinois universities. Discussion ensued. Chair Brookins noted that the Committee would defer action on this item and requested that President Green, or her designee, prepare recommendations regarding a policy for awarding president emeritus status.

Chair Brookins called upon the Faculty Senate Representatives to the Committee for remarks. Rashidah Muhammad reiterated that a thorough review of the Board's Bylaws, Policies, and Regulations was needed. She also noted that presidential emeritus status is different from faculty emeritus status. Marlon Cummins remarked that he felt a review of policies can be done expeditiously.

There being no new business, the meeting adjourned at 9:11am with a motion from Trustee Taboas and a second from Trustee Sebastian. The motion was approved by unanimous voice vote.
