	Immunization Record. This must include verification of a) measles/mumps/rubella b) varicella (chicken pox) immunization OR date of having disease signed by physician c) Hepatitis B immunization OR						
	d) a titre report indicating immunity to any or all the above 2-step Mantoux Tuberculin Skin Test (TST), QuantiFERON (QFT) or X-ray or written excuse from a physician (test choice needs to be current to one year).  Note: A 2 step is defined as two TST's done within 3 months of each other. The optimal time for testing would be to complete the 2 TST's within 1-4 weeks of each other.						
	Proof of current comprehensive Health Insurance. Photocopy of GSU ID.						
	Current CPR Certification (must be a skill course for HealthCare Providers, Internet CPR is not accepted).						
	Certificate of completion of Bloodbourne Pathogens Training (OSHA). The training is offered through the GSU library. <a href="http://libguides.govst.edu/universalprecautions">http://libguides.govst.edu/universalprecautions</a>						
	Certificate of completion of The Health Insurance Portability and Accountability Act (HIPAA) via course CDIS 8200: Foundations of Clinical Practice.						
	Certificate of Completion of Illinois mandated online training: Recognizing and Reporting Child Abuse (available through: <a href="https://mr.dcfstraining.org">https://mr.dcfstraining.org</a> )						
	Proof of ADA accommodations if appropriate.
