Admission Requirements

Applicants must meet, provide or show evidence of the following admission requirements:

1. Provide transcripts from a masters degree from an occupational therapy program accredited by ACOTE; International students must have graduated from a masters level program accredited by the World Federation of Occupational Therapy (WFOT).
2. A minimum graduate GPA of 3.0, on a 4.0 point scale;
3. Certification from NBCOT;
4. Current state occupational therapy license;
5. Application essay;
6. Curriculum vita or resume;
7. Three letters of recommendation; and
8. A virtual interview with a graduate program faculty advisor/mentor.
9. Completion of the DrOT graduate application;
10. Application Fee
