Special Admission Requirements

In addition to meeting university admission criteria, applicants must have successfully completed the following prerequisites in addition to, or in conjunction with, a baccalaureate degree:

Social & Behavioral Sciences Required: (9 Credits)

General Psychology - (3 credits) Abnormal Psychology - (3 credits) Developmental psychology or other related Life Span Development course - (3 credits)

- Human Anatomy and Physiology with lab (8 credits)
- Medical Terminology (1 credit)
- Orientation to Occupational Therapy (2 credits)

Additional Requirements and Interview Process:

- Students must have an undergraduate cumulative GPA of 2.75 excluding your freshman and sophomore year.
- A personal statement paper articulate why you are choosing occupational therapy as a career.
- Three letters of recommendation: One must be from a healthcare professional, one from an academic person; one from a mentor, employer, advisor, or volunteer experience supervisor.
- Interview by invitation based on review of application.
- A \$750 seat deposit is required upon acceptance.
