



Early Childhood Endorsement or Early Childhood Special Education Approval

Candidates who hold an Illinois Professional Educator License (PEL) and seek a subsequent endorsement (certificate only program).

EC SPED Approval: Candidates must hold a PEL and have an endorsement in Early Childhood Education.

Due to the ongoing teacher shortage, the current generation of children are at risk of receiving inadequate guidance that may impact their educational development. Licensed teachers can earn an advanced certificate to add a subsequent endorsement to their Professional Educator License (PEL). GSU offers coursework for teachers to earn endorsements in the early childhood field: Early Childhood (EC) Endorsement or Early Childhood Special Education (SPED) Approval.

Program Requirements

After meeting the university admission requirements, students must meet the following additional requirements to be admitted to and continue in the Early Childhood Education program:

- must have a valid Professional Educator License (PEL)
- must have a cumulative G.P.A. of 2.75 or higher on a 4.0 scale in all undergraduate work
- must earn a grade of "B-" or better in all teacher education coursework at GSU
- EC SPED Approval only: must have an endorsement in Early Childhood Education
