This notice provides you with a summary of important information that you need to know about Governors State University, including your rights and responsibilities as a student. ## **COVID-19 & Safe Return to Campus**

Congratulations – your concern and care for your fellow students, faculty, and staff, by following the required Covid Compliance procedures, have allowed us to maintain a relatively safe campus during fall semester, with few Covid infections reported (see <a href="Campus Dashboard">Campus Dashboard</a>). We hope to continue maintaining a healthy, Covid-free, learning environment for Summer Semester 2022. On campus we are maintaining social distancing where feasible, maintaining posted signage regarding compliance and safe health practices, offering a free rapid testing clinic, continuing to monitor our improved air quality and air flow throughout campus buildings, and will continue to make available masks and hand sanitizer in classrooms and in strategic places across campus. We continue to encourage you to do your part by maintaining compliance with our vaccination/testing requirements and wearing a mask that covers both nose and mouth, when inside campus.

Failure to follow the required safety procedures, including the posted procedures for COVID 19, or failure to comply with university employee instructions regarding Covid safety procedures, are in violation of the Student Code of Conduct (Policy 4 Student Conduct Policy) and may be subject to disciplinary action which may include removal from a class and removal from campus. Students are required to self-report symptoms or diagnosis of COVID-19 (e.g. fever, cough, difficulty breathing) or close contact with someone who has a lab confirmed or presumptive COVID-19 diagnosis by using the COVID-19 Reporting Form found on the COVID-19 webpage <a href="http://www.govst.edu/COVID-19-students">http://www.govst.edu/COVID-19-students</a>.

If you have been diagnosed, are experiencing symptoms (fever, cough, difficulty breathing), or suspect that you have been exposed to someone with coronavirus (COVID-19), please complete the <a href="COVID-19 self-reporting">COVID-19 self-reporting</a> form. This information will be used to help the Emergency Response Team assess risk to the campus community and deploy appropriate resources.

Students are also responsible for notifying their instructors by completing the <u>Student Absence Notification to Faculty</u> form so that appropriate course completion arrangements can be made.

#### **Student Absence Notification to Faculty**

A student may request faculty notification for a documented absence of 3 days or more due to:

- Personal prolonged illness or injury;
- Life-threatening or serious illness or injury of an immediate family member;
- Death of an immediate family member;
- Emergency work as defined in the Volunteer Emergency Worker Job Protection Act\*;
- Compliance with a valid subpoena, jury duty, or other legal matters such as citizenship or naturalization processes;
- Significant and compelling circumstances beyond a student's control such as an act of nature that causes destruction to a student's primary residence.

Absence notification is intended to provide faculty with verified information that they may use to determine whether or not to excuse the absence and/or permit late or make-up work. Absence notification neither guarantees that the absence will be excused nor ensures that late or make-up work will be permitted. This authority rests solely with individual instructors. #### **Student Code of Conduct**

The Student Code of Conduct, along with other University policies, will give you clear guidance on what you can expect from GSU faculty and staff, and what we will expect from you. The Student Code of Conduct is published in the <a href="Student Handbook">Student Handbook</a>, and includes the procedures that guide the <a href="Community Standards process">Community Standards process</a> to hold students accountable for violations of University policy, reflect on their behavior, and develop skills that promote personal and community responsibility.

#### **GSU4U: Connecting Students to Support Services**

<u>GSU4U</u> connects students to campus and community resources when they are facing personal difficulties, such as food and housing insecurity. We are dedicated to assisting all students experiencing personal difficulties no matter how serious or small the situation may seem. #### Financial Aid: Have you completed the FAFSA? Don't wait!

The Office of Financial Aid is committed to helping you research all options to make your education affordable. FAFSA applications for the 2022-23 academic year will open October 1, 2021. Apply early to maximize your aid package. If you have not already completed the 2021-22 FAFSA, the deadline to do so is June 30, 2022. Complete the FAFSA online using GSU's school code 009145.

#### **Privacy and Your Rights Under FERPA**

As required by the Family Educational Rights and Privacy Act (FERPA), GSU maintains individual student records for the purpose of providing services to the student. The University has an obligation to limit access to student information to school officials with a legitimate educational interest and to insure that data is stored securely to prevent unauthorized access. Information about FERPA, including a waiver to share your student information, is available from the Registrar.

## **Campus Safety and Security**

Establishing and maintaining a safe and secure environment for our staff, students, and visitors is of primary importance to GSU. The Clery Act is a federal mandate which requires that all current students and employees be provided with information on policies and procedures involving campus security, the reporting of criminal action or other emergencies, and the enforcement authority of security personnel. The Campus Security Report is available for review on the <a href="Campus Right to Know website">Campus Right to Know website</a> and in the <a href="Department of Public Safety">Department of Public Safety</a> (DPS), located in C1375.

#### **Title IX and Sexual Harassment**

Title IX is the comprehensive federal law that prohibits discrimination on the basis of sex in any federally funded education program or activity. In accordance with Title IX, the university prohibits discrimination on the basis of sex in all university activities and programs as outlined in the Title IX and Sex Discrimination, Harassment, and Retaliation Policy. Prohibited conduct under this policy, includes, but is not limited to, sexual harassment, sexual assault, dating violence, domestic violence, and stalking. If you or someone you know experiences sexual harassment, we encourage you to report it to the Title IX Coordinator so that we can maintain a community free of such conduct.

These standards are intended to be in full compliance with the Drug-Free Workplace Act of 1988 and the Drug-Free Schools Act of 1989. #### Optional Disclosure of Private Mental Health Information

Under the Student Optional Disclosure of Private Mental Health Act (110 ILCS 74/), students may designate an individual over the age of 18 to receive disclosures of certain private mental health information. Disclosure of a student's mental health information to a designated person may be made if a physician, clinical psychologist, or qualified examiner (i.e., clinical social worker) employed by the university determines that a student poses a clear danger to themselves or others. If you wish to designate a person that would receive certain private mental health information, please complete the Student Optional Disclosure of Mental Health Contact Information Form on the myGSU portal.
