### Refer a Student

As faculty and staff, you may come into contact with students who are struggling and/or in need of extra assistance. Not sure where to start? Refer students to the Office of the Dean of Students! Our team can help students navigate campus and community resources and find the best action plan for them.

### **Share Information**

Most university employees, unless specifically exempted, must immediately report:

- Serious infractions of the Student Code of Conduct, including, but not limited to: the destruction of property; possession of a weapon; use, sale, or possession of controlled substances (drugs); or violations of local, state, or federal law;
- Allegations or disclosures of sexual misconduct, including but not limited to sexual assault, sexual harassment, dating/domestic violence, and stalking; and
- Other behavior that poses an imminent risk to the safety of any member of the university community, including but not limited to threats or acts of violence.
